Privacy Statement of Habbeke Shipyard

This Privacy Policy applies to all visitors to the websites of Habbeke Shipyard or its affiliated companies, subsidiaries and combinations.

Through its service, Habbeke Shipyard will process privacy sensitive or personal data. Habbeke Shipyard values the privacy of its customers and observes due care in processing and protecting personal data.

Use of Personal Data

By using our service, you are providing certain data to us. This could be personal data. We only retain and use the personal data provided directly by you or for which it is clear that it has been supplied to us to be processed.

We use the following data for the purposes as mentioned in this Privacy Statement:

- Name
- Telephone number
- Email address

Contact Form

We have a newsletter to inform those interested of our products and/or services. Each newsletter contains a link with which to unsubscribe from our newsletter. Your email address will be added to the list of subscribers only with your explicit consent.

Location data

If necessary, we may collect your location data (GPS). If that is the case, you will be asked to grant consent beforehand.

This location data and other data can also be stored and processed by the provider of the navigation/mapping software, such as Google Maps, but the data could also be used by, for example, Google or Apple itself. We have no control over their actions. We recommend that you read the applicable privacy statement of the provider in question.

Publication

We will not publish your customer data.

Advertisements

Our service displays generic advertisements. We check whether people like it, and use that information to make only nice or interesting advertisements and offers in the future.

Providing Data to Third Parties

We may provide your data to our partners. These partners are involved in the execution of the agreement.

Our website features social media buttons. These buttons are used by the providers of these services to collect your personal data.

Cookies

Our service uses cookies. Cookies are small files where we can store information so that you do not have to enter it all the time. But we can also see that you are visiting us again.

When you visit our service for the first time, we present a notification with an explanation about cookies. If you subsequently continue to use our service, we assume that you have no objection to the cookies.

You can disable the placing of cookies through your browser, but some of our services will not work properly anymore.

Google Analytics

Security

- Access to personal data requires the use of a user name and password
- After receipt, the data will be stored in a separate system
- We make use of secure connections (Secure Sockets Layer of SSL) to encrypt all information between you and our website when entering your personal data
- We keep logs of all requests for personal data
- We are ISO 27001 certified
